All KPC members are expected to abide with the following KPC Code of Conduct. Members must:

- Review and abide by the Bylaws contained within The KPC Handbook.
- Abide by any additional Codes of Conduct specific to social media platforms endorsed by The KPC (i.e., Facebook groups).
- Treat all KPC members and guests fairly, equally, and with respect and courtesy.
- Not physically or verbally harass or discriminate against others.
- Be supportive of other member's work during photo reviews. Any criticism should be constructive, and not malicious or demeaning of a member's work.
- Never use another member's work without his/her express written permission.
- Respect private property & facilities used for KPC meetings, activities, outings, photo shoots, etc.
- Act/ behave in a manner that protects the member's personal safety as well as the safety of other members and members of the public.
- Not by word of mouth while making images nor through deed, behaviour, or action cause the name of The KPC or any of its members to be brought into disrepute.
- Always put the welfare and safety of all animals and plants ahead of making an image of them.
- Complete a model release form when photographing a model or member of the public by request of the KPC. Street Photography is exempt. See **Ontario Photographers Rights** on page 26 of the KPC Handbook
- Not claim to be acting on behalf of The KPC without the written consent of the KPC Executive.
- At all times act in accordance with applicable laws (i.e., Copyright laws, Privacy laws, Trespassing laws, Pornography laws, Highway Traffic Act Laws, etc.) Violation of any law is the legal responsibility of the member.
- Agree to give The KPC non-exclusive permission to use any images submitted through website submission portals for KPC publications, promotions or social media platforms; for storage on KPC archives and/or selection for CAPA submission. The member may specifically, in writing, refuse to grant this permission, and
- As personal courtesy to all members, turn off or silence personal communication devices that would interrupt KPC activities. When on Zoom meetings, mute microphones when directly not needed, and turn off cameras when standing up, leaving seat, or doing other activities when attending the meeting.
